- ✓ **STAKES PLACED AT SARATOGA:** In her 4-year-old season, Animal Appeal **NEVER** finished out of the money in 6 starts. She strung together a series of impressive efforts posting Beyers of **85-90-96-90** at Belmont and Saratoga. At the close of the Saratoga meet, Animal Appeal went off as the **even-money favorite** against **open-company** in the **\$100,000 Smart N Fancy Stakes**. She earned **black type** for her effort and was narrowly defeated by **G3W Fair Point** and **G3W/G2P Miss Ella**.
- ✓ **BLAZING SPEED:** Animal Appeal's signature move was to break on top and never look back, routinely posting ½ miles in :44 seconds. In each of her four lifetime wins, Animal Appeal found herself comfortably in front of the rest of the field and once they turned into the stretch, the others just couldn't catch her. Furthermore, she **wired** an allowance field at Belmont over **6 furlongs in 1:07 flat**— just 1/5th off of the **track record**.
- ✓ **MODEL OF CONSISTENCY:** Animal Appeal raced **exclusively on the NYRA racing circuit** outside of a single start at Pimlico on Preakness Stakes Day which she came in to off of an 8-month layoff. In these **13 starts on the NYRA circuit**, Animal Appeal was dubbed the betting **favorite** in 9 of these outings. This heavy favoritism was backed up by her ultra-consistent performances as she finished **11** of these starts **in the money (85% ITM)**.
- ✓ **LEROIDESANIMAUX AS A BROODMARE-SIRE:** The daughters of Leroidesanimaux have produced 71 starters. These 71 starters account for 45 winners (63%) and **6 Graded Black Type/Black Type performers (8%)**. Additionally, his **Black Type-daughters** have only produced **14 foals of racing age**— 7 are starters and 6 have gone on to win (**85% starters → winners**). The average yearling auction price of his daughters' progeny at auction is \$76,000 but this number **spikes dramatically** when referring to the **yearlings** out of his **Black Type-daughters** which **sell for an average of \$204,000**.
- ✓ **IN FOAL TO TWIRLING CANDY:** Animal Appeal is being offered in foal to Lane's End-sire TWIRLING CANDY on a **February 26 cover**. In his 4 crops of racing age, Twirling Candy has sired **14 Graded Black Type/Black Type winners and 19 Black Type placed horses** firing at a **15% strike rate** of starters → Black Type performers. His active performers include **G1W Finley'sluckycharm (Breeders' Cup bound)**, **G1P Sweetontheladies**, **G3W Morticia**, **G2P Gianna's Dream** and 2-year-olds **SP Stupify** and **SP Candy Lane**.

Most recently, Twirling Candy's undefeated **G2W Concrete Rose** cruised to victory in the Breeders' Cup "Win and You're In" Jessamine at Keeneland becoming one of the **favorites** for the **Juvenile Fillies Turf**. His current 2-year-olds are **36% runners → winners**.
- ✓ **ELIGIBLE AS A NEW YORK RESIDENT MARE:** After her February 26 cover date with Twirling Candy, Animal Appeal shipped back to New York where she has resided up until the sale. After purchase, if she returns to New York State, her foal will be eligible to be registered for the lucrative New York-bred program.

SEPTEMBER 25, 2015 - \$60,000 MAIDEN SPECIAL WEIGHT AT BELMONT

Going off as the favorite in her 4th lifetime start, ANIMAL APPEAL blazed to the front of the field right out of the gate. She handily strolled through fractions of :22¹, :44⁰ and :56² leading the group throughout. Awaiting her cue from jockey Luis Saez, Animal Appeal kicked away from the 1/8th pole and kept on to win by 1 1/2 lengths.

JUNE 15, 2016 - \$62,000 ALLOWANCE-1X AT BELMONT

Once again dubbed the betting public's choice, ANIMAL APPEAL showed her **lightening turn of foot** to establish her position as soon as the gates opened. She led the field by 4 lengths throughout setting fractions of :21⁴, :44⁰, and :55² before accelerating into another gear to draw off by **4 1/2 lengths on the wire**. She earned a **90 Beyer** figure and stopped the clock in 1:07- **1/5 of a second off of the track record**- while carrying **top weight** in the field.

JULY 25, 2016 - \$78,000 ALLOWANCE-2X AT SARATOGA

For her 3rd lifetime victory, ANIMAL APPEAL assumed her typical running style to break on top and never look back. A quarter of a mile in, she was already 3 lengths in front of the field and increased that lead to 7 lengths entering the stretch, drawing away on the wire to defeat **SW Startwithsilver**, **SW Dreamboat Annie** and **SP Little Bear Cat**.

AUGUST 28, 2016 - \$100,000 SMART N FANCY STAKES AT SARATOGA

Stringing together a very strong campaign over the summer of 2016, ANIMAL APPEAL advanced from NY-bred restricted races to an open company Stake at Saratoga. After her dominant victory over the same course in her last start, Animal Appeal went off as the even-money favorite against open company. Setting swift fractions, she led the field up until late-stretch and was just caught on the wire by **G3W Fair Point** and **G3W/G2P Miss Ella**.

JUNE 18, 2017 - \$77,000 ALLOWANCE-N1X AT BELMONT

After a long 4 year old season, ANIMAL APPEAL was given time off over the winter and brought back mid-year of her 5-year-old season. In her return to the New York racing circuit after 9 months off, ANIMAL APPEAL got back to her winning ways against open company breaking sharply and wiring the field to win over the yielding turf course by a neck on the line.

SUMMARY

As a racehorse, ANIMAL APPEAL was the model of consistency **running in the money 85%** to earn over **\$220,000**. Not only was she consistent, but she was also **fast**— wiring an Alw field at Belmont over 6 furlongs in 1:07 flat (**1/5th off** the existing **track-record**). She is a **Black Type daughter** of LEROIDESANIMAUX offered in foal to the **Lane's End-sire**  **TWIRLING CANDY** . A New-York Resident Mare, if she is shipped back to the state after the sale, Animal Appeal's progeny will be eligible to be registered for the lucrative New York-bred program.
