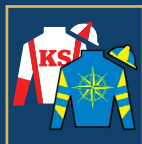

CALL PROVISION earned a **career best (2³) Thoro-Graph** when last seen in the Ashley T Cole at Belmont Park.

That number is just shy of the **(2²)** that CHANNEL CAT earned when winning the **G2 Bowling Green** at Saratoga earlier this year and also when running **2nd in the G1 United Nations**. As if his past performances didn't already show he can be competitive at the top level of horse racing, his sheet numbers certainly do.

SUMMARY

Being a **New York-bred** allows Call Provision to run for some **serious state-bred money**. However, he is one of those New York-breds who **has the talent to compete against the best in open company**.

He is a classy, older turf horse and is **back on the worktab** at Saratoga making him a **prime candidate to go on with over the winter**. **Stakes going long on the turf include but are not limited to:**

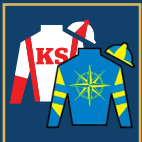
