PAST PERFORMANCES

At two, PLEASE FLATTER ME won both the Blue Mountain Juvenile and Gin Talking (Click to view race replay) by a combined 9 3/4-lengths to close out her 2-year-old season undefeated after breaking her maiden in her debut by 8 1/2 lengths. In all, Please Flatter Me won her first three starts by a combined 18 1/4-lengths.

At three, PLEASE FLATTER ME stepped up in class in the **G3 Miss Preakness where only dual Champion COVFEFE was good enough to beat her**. Please Flatter Me was well clear for 2nd, **finishing several lengths in front of seven other stakes winners**, including eventual **Grade 1 winner FIGHTING MAD (Click to view race replay).**



PLEASE FLATTER ME wins the Gin Talking at Laurel by 5+ lengths.

PAST PERFORMANCES

Returning to Laurel Park for the Alma North S., PLEASE FLATTER ME **resumed her winning** ways with a 3/4 length victory for her **3rd career stakes win**, beating 5 stakes winners including **G3W VICTIM OF LOVE (Click to view race replay)**.



PLEASE FLATTER ME wins the Alma North as a 3-year-old.

Making her four-year-old debut at Churchill Downs in June, PLEASE FLATTER ME ran a good 2nd in a stakes quality allowance, only missing out to the multiple G1W GUARANA.

From her 10 lifetime starts,
PLEASE FLATTER ME was
precocious enough to go
undefeated as a 2-year-old,
earned 3 Stakes victories and
a G3 placing while finishing in
the top-2 in 60% of starts.

PEDIGREE



JACK CHRISTOPHER impressed once again at The Spa on Saturday for Chad Brown

- 1st H Allen Jerkens Memorial Stakes [G1], Saratoga, by 11/4 L.
- 1st Woody Stephens Stakes [G1], Belmont Park, by 10 L.
- 1st Champagne Stakes [G1], Belmont Park, by 2¾ L.
- 1st Pat Day Mile Stakes [G2], Churchill Downs, by 3¾ L.
- 1st Maiden Special Weight, Saratoga, by 8¾ L.

MUNNINGS

Sire of more Stakes winners in 2022 than any other sire in North America bar INTO MISCHIEF

Others include **KIMARI** (G2SW in 2022, G1SW in 2021), **EDA** (G3SW in 2022, G1SW in 2021) etc.

PLEASE FLATTER ME is by top filly sire MUNNINGS, whose 52 stakes winners include JACK CHRISTOPHER, recent winner of the G1 Allen Jerkens at Saratoga and KIMARI, winner of the G1 Madison at Keeneland.

His stud fee was increased to \$85,000 (from \$40,000) in 2022 and his profile continues to rise. His 13 Stakes
Winners in 2022 are more than any other sire except for INTO MISCHIEF.

IN-FOAL TO VIOLENCE (A)

PLEASE FLATTER ME is **offered in-foal to VIOLENCE**, the leading 6th crop sire for 2022.

His top priced yearlings at the 2022 Keeneland September sale brought: \$325,000, \$300,000, \$300,000, \$220,000, etc.

Where VIOLENCE's progeny truly shine is on the track. He is represented by 6 Stakes winners and 2 Graded Stakes winners in 2022, led by **Breeders' Cup**Juvenile contender FORTE.

PEDIGREE



PLEASE FLATTER ME was **put** in **foal to Triple Crown winner JUSTIFY for her first mating**. Sadly, her 2022 filly had to be euthanized after a paddock accident. She is **back in-foal to VIOLENCE** on a May 25th cover.

SUMMARY

By one of the **hottest sires in the business**, **MUNNINGS**, PLEASE FLATTER ME was a **precocious dirt filly** with speed to spare who held her own against some of the best

fillies in her division.

She proved to be **consistent throughout her career** with top two
finishes in six of her 10 starts with one
other loss coming by just a length.

VIOLENCE her in-utero foal is bred on

a similar cross to G3W

ROCKEFELLER, winner of the G3

Nashua and runner-up in the

G3 Sham.
